

## **Board of Fire Commissioners, District II**

**November 3<sup>rd</sup> 2025**

Board President Cliff Sharp opened the meeting at 6:30 PM.

The American Flag was then saluted, and the Lord's Prayer was recited prior to the start of the meeting.

### **Members participating were:**

### **Minutes**

### **Treasurers Report:**

The ending check balance was \$109,379.19. Fund balance of checking and savings is \$314,368.50. The total assets of the fire district as shown are \$485,960.48. A motion to accept the report and pay the bills was made by Fred Hundt and was seconded by Ronald Hundt Sr.

It has also now been determined that the Cable needs to be upgraded also to complete this.

Fred Hundt made the motion to have this upgraded and it was seconded by Ron Hundt Sr.

**New Business:**

Megan Sheppard brought to the attention that she has did her upgrade and recerts for holding her EMT statis. The fire commission will reimburse her expenses. Good job Megan.

**Chiefs Comments:**

Fred asked if we found out why the commission is not getting billed from the County Fire School for training. No one seemed to know, so it was tabled until next month.

Mark presented information pertaining to old gear that is beyond the division's requirements. Mark is claiming that the State is now allowing apparatus drivers to wear non-compliant turnout gear while operating the unit at the fire scene. Fred said he's happy with that decision because it opens the door for others to be on a scene that are not compliant. There was a lot of discussion on this, and we are sure there will be more discussions and clarifications at the next meeting.

Mark asked the fire commission to purchase 12 vests to be used on the scene. He was given the approvals to purchase these vests. They will purchase without with out a quote because the cost will be below the State required bid if over \$500.00

Motion to purchase these vests made by Fred Hundt and seconded by Ron Sutton Jr. All present voted yes.
